## STERLING LANES 2024 USBC JUNIOR GOLD CHAMPIONSHIP QUALIFIER

1. This tournament is open to all USBC certified youth bowlers during the 2023-2024 season. All youth bowlers participating in this tournament must present their USBC certification card at check-in. Proof of membership is required. Check-in begins 1 hour before start time. Walk-ins will be accepted if space is available. Tardy bowlers will receive a zero for all frames missed. Participants bowling in an adult league will not be allowed to participate in this event.
2. All bowlers must be members of USBC Jr. Gold prior to qualifying. Membership may be purchased before the beginning of the event for $\$ 30$ for participants in the UI5, U18, divisions and $\$ 10$ for the U12 division. Proof of membership is required.
3. This is a scratch tournament. NO handicap will be given. Participants will bowl 5 games across 5 different pairs of lanes. The lane pattern will be posted on the day of the tournament.
4. A Jr. Gold entry will be awarded to the top finishers in each division that has a minimum of 5 bowlers in that division. Standings will be determined by total pins for 5 games. Any ties will be broken by a 9th and 10th frame roll off.
5. Entry fee for this event is $\$ 60$ ( membership fee NOT included). Fees divided as follows: linage: $\$ 20$, Prize fund: $\$ 40$. Practice only entry will be $\$ 20$, these bowlers will not be eligible for a spot. Payment may be made by cash, check, or credit card. Checks should be made out to Spins Bowl Sterling Heights with the memo reading "Jr gold qualifier Sterling Lanes." Space is limited to the first 60 entries paid. 24 hour advance notice to the tournament director is required to receive a full refund of the entry fee if the bowler will not be participating. Late cancellations and no-shows will forfeit their entries.
6. Only bowlers and tournament officials are allowed in the bowlers area during the tournament. All score corrections and problems require a tournament official to be present.
7. Proper attire is required for this event. Hats, Sunglasses, and non-religious headgear are not permitted. There can be no swearing or offensive language. Abuse of equipment or furniture at the center is not permitted. Failure to abide by these rules may result in immediate disqualification from the tournament and loss of entry fee.
8. All bowling balls uses in the event must meet USBC specifications and all bowling ball surface changes must conform to USBC Rule 18- bowling ball altering surface. Failure to follow these rules will result in immediate disqualification from the tournament and loss of entry fee.
9. All protests are to be made by the bowlers, any outside objections will not be heard. All protests must be submitted to the tournament director within 15 minutes of the last bowler to complete the event. The tournament director reserves the right to ask any person to leave the bowling center if their conduct is detrimental to the tournament operation.
10. The tournament director has the right to refuse any entry. The bowler, by voluntary participation in the event, agrees to the final authority of the tournament director to interpret and enforce all rules, regulations, and procedures. Any unforeseen or not described situations will be regulated by USBC rules with interpretive judgment guided by the best interest of youth bowling and this event. USBC rule 400 will be observed.
